1. Be first to be recognized by the presiding officer.
2. Step up and speak from the podium.
3. State your name and address for the record.
4. Limit your comments to three (3) minutes unless granted an extension of time.
5. Speak to the issue of concern. Personal attacks shall not be tolerated, and the Council reserves the right to remove abusive persons from council chambers.
6. Please do not interrupt or disrupt the conduct of the Town's business.
7. If you have an issue with an individual Town employee, please schedule a time to come talk to the Town Manager regarding your concerns.
