Imposing and Categorizing Taxes and Levy Taxes

RESOLUTION NO. 1181

**WHEREAS**, the Town of Lakeview has appointed a Budget Committee on May 12th to review financial data on the operations of the Town and reviewed a proposed budget for the 2026-2027 fiscal year for the town; and

**WHEREAS**, the Town of Lakeview has appointed Mayor Marc O'Brien as the budget officer for the proposed budget for 2026-2027; and whereas the Town Council has set June 10<sup>th</sup> for the first meeting of the Budget Committee and June 16<sup>th</sup> as a date for a second budget committee meeting, if necessary; and

**WHEREAS**, on June 23, 2026 the Town Council has set a Budget Hearing to approve a proposed budget for fiscal year 2026-2027 and recommended it to the Town Council; and

**WHEREAS**, the Town Council has set a special session on June 30, 2026 to consider and finally adopt the Town of Lakeview budget for the fiscal year of 2026-2027; and

**WHEREAS**, proper public notice was given in which the citizens had the opportunity to provide written and/or oral comments or ask questions for the authorities responsible for the adoption of the budget for the Town of Lakeview for the Fiscal Year 2026-2027 at the public hearing held on June 23, 2026; and

**WHEREAS**, this accelerated timeline is necessary due to the resignation of four out of the five Town Council members, the Town of Lakeview is publishing this timeline to provide timely and adequate public information to ensure that the citizens of Lakeview can participate and be informed of the all matters related to the final adoption of the official budget for the Town of Lakeview.

**NOW THEREFORE BE IT RESOLVED** that the Town Council of the Town of Lakeview hereby adopts the following schedule for the 2026-2027 budget process; and

**BE IT FURTHER RESOLVED**, that the Town Council will state the official rate per \$1000 of assessed valuation on June 23, 2026 in order to provide this information in a timely manner prior to final adoption and the imposition of property taxes which will hereby be imposed upon all taxable property within the Town of Lakeview as of 12:02 July 1, 2026; and

**BE IT FURTHER RESOLVED**, subject to Section 1. of ORS 221.770. The Town will elect to receive state and local revenue for fiscal year 2026-2027; and

**BE IT FURTHER RESOLVED**, that the Town Council will elect to continue to collect Marijuana Tax revenue for 2026-2027; and


**BE IT FURTHER RESOLVED**, for the fiscal year beginning July 1, 2026 the Town will publish the amounts appropriated and ending June 30, 2027 in detail within the funds listed on June 25, 2026.

**BE IT FINALLY RESOLVED**, the Town Council will certify to the Lake County Assessor the tax levy made by this resolution and filed with the County Clerk a copy of the budget as finally adopted.


